HOW FAMILIES ARE SELECTED

Our Family Selection Committee is comprised of volunteers and Habitat staff. They have the difficult task of choosing fourt to six families out of the many who apply each year.

- Families attend an orientation session and complete a detailed application
- 2. Committee members analyze the applications
- Qualifying families are visited at their current residence to assess the need for better housing and willingness to partner
- The Habitat St. Charles County Board of Directors selects partner families from the slate of candidates recommended by the Family Selection Committee



Getting Ahead is Harder than Ever

HOUSING COSTS ARE RISING

- As of 2020, the median rent in St. Charles County was \$1,450 and the median price of a house was \$280,000
- Six out of ten households earning \$50,000 or less annually are cost burdened
- A home is considered affordable if no more than 30% of the household income goes toward housing costs, consequently if

23,000 households are cost-burdened*

- someone in St. Charles County wanted to rent on a minimum wage income, they would spend over 68% of their income on housing costs alone
- We help provide healthy homes, safe and free from environmental or physical hazards, promote good physical and mental health

NEGATIVE IMPACTS OF SUBSTANDARD, UNAFFORDABLE HOUSING

- Increased risks for chronic diseases, injuries and harmful effects on childhood development
- Poor student performance and low academic achievement

Own a Decent and Affordable Home

- A Habitat St. Charles County family, like every homeowner, pays a mortgage and contributes to real estate taxes
- Because mortgage payments are kept to 30% of a family's income, they are able to afford other necessities many of us take for granted - healthy groceries, clothing for growing children, and utilities
